### **Projected Expenses/Monthly:**

State your expected monthly maintenance and mortgage figures for the <u>coop</u> <u>apartment</u> you are bidding on.

## **Itemized Schedules:**

Provide an itemized schedule of the assets, liabilities and other income listed on page one of the REBNY financial statement.
